IMPORTANT INFORMATION FOR SEPTEMBER 14, 2021 LITTLE ROCK SPECIAL ELECTION

LITTLE ROCK -- Pulaski County Circuit and County Clerk Terri Hollingsworth reminds voters the special election is set for September 14 for voters who reside in the city limits of Little Rock. Voters will decide on the proposed one-percent sales-tax increase.

There are approximately 128,000 eligible registered voters for this election. Residents who are unsure if they are qualified to vote can use the voter information site voterview.org on the Arkansas Secretary of State's website to check a sample ballot and find their polling location. The last day for new voters to be qualified to vote in this election was August 16. The last day voters can transfer their voting address within the city limits and be eligible to vote will be September 10.

EARLY VOTING

There are five days of early voting beginning Tuesday, September 7 and ending Monday, September 13. There will be no early voting on Saturday or Sunday. The hours for early voting will vary with the main site, Pulaski County Regional Building open from 8:00 a.m. until 5:00 p.m. The six offsite early voting locations will be open at 10:00 a.m. and close at 5:00 p.m.

ELECTION DAY

Pulaski County voters will need to vote at their assigned polling location on Election Day. The polls will be open from 7:30 a.m. until 7:30 p.m. There will be no vote centers open for this election.

ABSENTEE VOTING

Pulaski County voters and/or their designated bearer have until September 10 before 5:00 p.m. to request an absentee ballot application. Due to new election laws regarding absentee voting, an absent ballot returned in person by the voter and/or designated bearer must be returned at the Pulaski County Courthouse the **Friday before Election Day**, September 10 before 5:00 p.m. Absentee ballots that were mailed in must be received by the County Clerk's Office before 7:30 p.m. on Election Day.

Voters who wish to vote by absentee ballot can submit their request in person at the courthouse at 401 West Markham Street, or by email, mail or fax to the voter registration department.
